WHO CAN BECOME A PSCQ 2010 MEMBER?

All Children's Services are encouraged to become a PSCQ 2010 Member including Long Day Care, Outside School Hours Care, In-home Care, Family Day Care services and Inclusion Support Agencies. Individuals are also able to become Members outside of their Children's Service.

MEMBERSHIP

WHAT ARE THE DIFFERENT TYPES OF MEMBERSHIP?

There are many different types of Membership, each designed to suit different circumstances. Please read carefully through the following types of Membership to decide which best suits you.

TARGET GROUP MEMBERSHIP (previously "eligible" membership)

Australian Government approved Child Care Services (those that receive Child Care Benefit (CCB)) are considered to be PSCQ's Target Group. Services encompassed under the Inclusion and Professional Support Program are also in the Target Group.

There are four sub-categories of membership under Target Group Membership. These are: Single Service; Organisation; Family Day Care Scheme; Individual.

Target Group Membership - Single Service

Cost: \$75.00 GST Free

Recommended for Long Day Care and Outside School Hours Care Services that are either:

- not part of a larger organisation
- are part of an organisation with less than five service sites

Once the service has become a Target Group Member, all staff that work within that service will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010.

Target Group Membership - Organisation (5+ services)

Cost: \$70.00 GST Free per site - minimum of five sites.

Recommended for Long Day Care and Outside School Hours Care Services that are part of an organisation with more than five sites. Upon becoming a PSCQ 2010 Member, each site wishing to register must be clearly outlined on the registration form. Once the sites have become a Target Group Member, all staff that work within those sites will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010.

Target Group Membership - Family Day Care Scheme

Cost: \$75.00 GST Free per site.

Recommended for Family Day Care and In-Home Care Schemes. Once the scheme has become a Target Group Member, all carers that work within that scheme will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010.

Target Group Membership - Individual

Cost: \$30.00 GST Free per site.

Recommended for Individuals who wish to become members, external of their place of enrolment. Once individuals have become a Target Group Member, they will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010

NON-TARGET GROUP MEMBERSHIP (previously "non-eligible" membership)

Services which are not Australian Government approved Child Care Services (those receive in the Child Care Benefit (CCB)) are considered to be PSCQ's Non-Target Group. There are three sub-categories of membership under Non-Target Group Membership. These are: Other Children's Services; Other Services; Individual.

Non-Target Group Membership - Other Children's Service

Cost: \$275.00 Inc GST

Recommended for Children's Services that do not receive Child Care Benefit, such as Kindergartens, Creches or Playgroups. Once the service is has become a Non-Target Group Member, all staff that work within that service will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010.

Non-Target Group Membership - Other Services

Cost: \$770.00 Inc GST

Recommended for other services, such as a Registered Training Organisation. Once the service is has become a Non-Target Group Member, all staff that work within that service will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010.

Non-Target Group Membership - Individual

Cost: \$165.00 Inc GST

Recommended for individuals who wish to become members, who do not work within a Children's Service that receives CCB, and who's service does not want to become a member. Once individuals have become a Non-Target Group Member, they will be eligible to take part in PSCQ's Membership Benefits until 31 December 2010.
