Since the launch of The Early Years Learning Framework (EYLF) in July last year, early childhood educators have been expected to familiarise themselves with it and to begin to map their existing practice against the principles and practice outlined in the Framework.

This session will assist you to become familiar with the document, have the opportunity to network with other early childhood educators and to feel confident about commencing the process of using it within your service if you have not already begun.

- Why has it been introduced? The background to the introduction of the EYLF
- Understanding the vision for children's learning - Belonging, Being & Becoming
- Introducing the Elements of the Framework – Principles and Practice, Learning Outcomes for children birth to 5 years
- Beginning to use the Framework in every day practice
