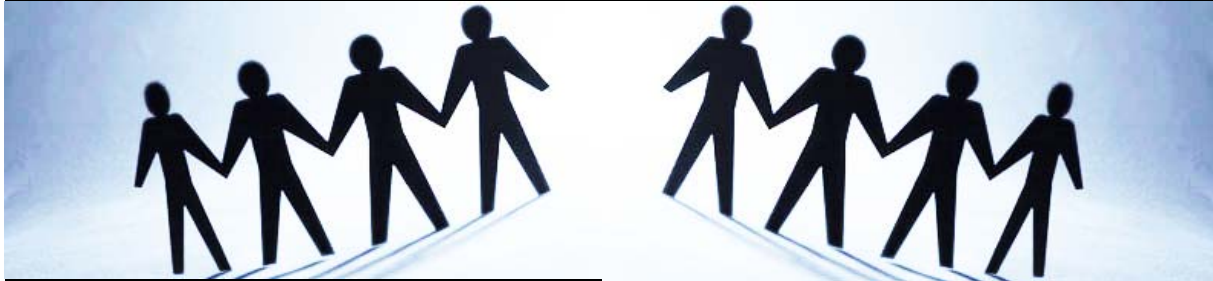


PEER SUPPORT GROUPS
