The Office for Early Childhood Education and Care The Office for Early Childhood Education and Care has responsibility for the current licensing of early childhood education and care and will continue to monitor and manage implementation of the new nationally consistent quality framework in Queensland including nationally agreed legislation, overseen by a new national body, from 1 January 2012. The Office representative at this session will provide an update on the National Quality Framework including the gradual implementation of the national quality standards for long day care, family day care, outside school hours care and kindergarten services from July 2010.

Family Day Care Association Queensland (FDCAQ) The session will provide participants with an opportunity to explore the NQS from a FDC context: consider the similarities of this integrated system to previous system and legislation; identify the challenges and opportunities this new National Quality System may provide.

Sunshine Coast TAFE Michelle Reber is employed by Sunshine Coast TAFE as Quality Assurance Support Officer for Long Day Care services in Queensland. She has supported over 300 services who have been either unsuccessful in the Accreditation process, new services and services with new Directors that are about to go through the process. Michelle has delivered workshops statewide to inform and support early childhood educators. Michelle has over 15 years' sector experience, has been a childcare educator at TAFE, a validator for NCAC and holds an Advanced Diploma in Children's Services.

Queensland Children's Activities Network (QCAN) A qualified and experienced facilitator from QCAN will work through the implementation of the National Quality Standard as it related specifically to OSHC. Participants will have the opportunity to work through a mapping process between the current frameworks with regulation and quality and contextualize these within the NQS Framework. Practical strategies for implementation will also be explored along with gaps between current practice and NQS expectations.
